Subject: Waste management and fight against incivility

Dear Madam, dear Sir,

The City of Beausoleil is committed to improving the living environment related to waste management and fight against incivilities.

An inventory undertaken by the Municipality in collaboration with CARF highlights a worrying situation regarding illegal dumpings of all kinds (overflowing bins, piles of trash bags around the containers, bulky wastes), which leads us to **remind you of the regulations related to the management and disposal of wastes.**

You will find, enclosed to this letter a poster which summarizes these regulations. The adjacent QR code will lead you to the sorting guide published by the CARF.

Should you be at the head of the union council of your building, I would be grateful if you could contact the secretariat of the "Quality of Life / Sustainable Development Department" at 04.92.01.02.04 in order to jointly define the best way to disseminate in the lobby of your building information about waste collection (household waste, selective sorting and bulky items).



You are not allowed under any circumstances to deposit your waste, whatever it be, on the public domain in an anarchic manner, neither on the ground, nor near voluntary waste drop off points.

The City of Beausoleil is making every effort to ensure that this regulation is respected. In this context, the Municipal Police carries out public road surveillance. People responsible of any illegal waste dumping will be identified and the lawbreakers will be penalized, as provided for in the Penal Code, with a fine of up to € 1,500.

Please be sure that the Municipality's determination to carry out this action remains unflinching in that regards. Its success is undoubtedly of common interest since it is part of a willingness to improve your living environment but also to enhance your heritage.

Finally, convinced that you can also be a source of proposals, the Municipality would like to invite you to participate in a citizens' convention on this subject. You will find here below an application form that can be filled and sent online or drop it off at the town hall.
